Dear readers,

Autism Alliance of Canada is proud to present an impact report for the 9th Annual Canadian Autism Leadership Summit (CALS2023), highlighting the remarkable success and significance of this event for our members and the autism community. Find out more about the diversity and reach of CALS2023, and feedback from attendees. This report informs the direction of our future Leadership Summits and ensures effective oversight and accountability for the Alliance.

CALS2023 was hosted from April 17th to 19th, 2023 at the Delta Hotels By Marriott Ottawa City Centre and via livestream. With over 250 attendees from across Canada and around the world, CALS2023 brought together the collective voices of Autistic self-advocates, service providers, policymakers, government representatives and international thought leaders in support of Canada's first ever National Autism Strategy.

We were pleased to welcome Minister Jean Yves Duclos, to address the meeting and were honoured to be recognized as a key partner in the further development of a National Autism Strategy.

With Canada on the verge of a National Autism Strategy (NAS), CALS2023 convened national and international experts to help inform autism policy at the national level and effective collaborative practices at the provincial/territorial level. CALS2023 also addressed the critical topics of housing and post-secondary education supports in the autism sector and the need for meaningful inclusion.

We are incredibly proud to report the following outcomes from CALS2023:

- Authentic engagement with Autistic participants, family members, researchers, politicians, service providers and policy makers from across the country;
- Presentation of the 2nd Annual Jim and Ginette Munson Award to Tom Jackman, Autistic advocate for acceptance of people on the autism spectrum;
- Provision of scholarships to 11 Autistic participants with lived experience who attended CALS2023 as part of our CALS2023 Financial Support Program;
- Presentation of opening remarks by the Honourable Jean-Yves Duclos, Minister of Health, which included his <u>announcement of funding for a</u> research initiative by Autistics for Autistic Adults;

- Sharing of lessons from international leaders with direct experience and success in the development and implementation of National Autism Strategies and related policies, providing us with excellent examples and frameworks that can have relevance to our upcoming work on the NAS;
- A robust discussion with regional representatives across Canada on how collaboration can be bolstered in anticipation of a National Autism Strategy;
- A powerful presentation by leaders from Indigenous communities who shared perspectives on autism in their communities, including the current barriers that families face, and articulating of a call to action for partnering with Autism Alliance of Canada to develop and implement meaningful research related to their unique needs;
- Presentations and dialogue that shed light on topics of pre-employment, housing, as well as strategies for advancing the collective work of our priorities together;
- Celebration of the passing of Bill S-203, "Federal Framework on Autism Act," at a reception sponsored by The Honourable George J. Furey, K.C, Speaker of the Senate.

This event and its success are a direct result of the support of our members, meeting attendees and the 18 corporate supporters all of whom contributed to the outcomes of CALS2023 and the charting of our path for the coming year. 
Session Highlights



Keynote Discussion

A Conversation with International Policy Experts: How do your autism policies help Autistic people?

This panel, moderated by the Hon. Wanda Thomas Bernard (Canadian Senator) welcomed international policy experts from the United States, Europe, and Malta. Panelists discussed how autism strategies in their countries have enhanced the lives of Autistic people and their loved ones, and shared their advice as Canada embarks on establishing its own National Autism Strategy. Key suggestions for Canada included ensuring ownership and accessibility, prioritizing implementation, embedding the strategy into legislation, fostering societal flexibility, building an inclusive advisory committee, and remaining realistic and open to compromise.






Panel Discussion

Using a Rights-Based Approach to Look at Autism Policies Around the World

Autism Alliance of Canada-Kids Brain Health Network Policy Development Fellows shared the stage with Lawyer, Sarah Ewart, and self-advocate, Yvonne Spicer, to provide insight into the alignment of national autism strategies with the Convention on the Rights of Persons with Disabilities (CRPD). Amplifying the perspectives and experiences of Autistic persons, panelists also highlighted promising practices from current strategies, and discussed experiences that other nations can learn from.

Presentation

An Update on the National Autism Strategy

Mark Nafekh (Director General, Health Promotion and Chronic Disease Prevention Branch, Public Health Agency of Canada) presented an update on the National Autism Strategy. **The Honourable Jean-Yves Duclos** (Minister of Health) announced that the Government of Canada is providing \$215,000 to the Alliance to support the needs of Autistic adults aged 30 and over.

Panel Presentation

Centering Indigenous Perspectives: How can a Federal strategy help?

Panelists highlighted gaps in access to services in Indigenous communities, the need for better support for students, teachers and parents in the school system, the importance of grassroot perspectives in research and decision making, and the key role language plays in creating understanding and awareness of autism/neurodiversity in Indigenous communities. Panelists also provided actionable items for both the federal government and community members on how to better support neurodiversity in Indigenous communities, and shared a strong willingness to work with the federal government to lead initiatives to foster the inclusion of Indigenous communities.

Panel

What do our Provinces and Territories need from a National Autism Strategy?

Canadian provincial and territorial governments and their community partners were invited to discuss what is needed at the regional level to improve services and support for Autistic people and their loved ones in the context of a National Autism Strategy. The panel highlighted the following key focuses for a federal autism strategy to improve social and political inclusion: (1) Consistent and timely diagnostic assessments to reduce wait times and ensure equitable access; (2) Revision of the funding model to provide support based on individual needs; (3) Active engagement of stakeholders; (4) Collaboration among provinces and territories to establish an integrated system of support; (5) Development of a comprehensive framework and national approach that brings together key players from all provinces and territories; and (6) Adequate funding for autism services and support, moving beyond tax credits and integrating various funding sources across multiple departments.



Experience

Autism Alliance of Canada requested specific feedback and suggestions from CALS2023 attendees regarding the interactive activities, barriers experienced, accommodations requested, and overall features of CALS2023.

Here's what attendees had to say:

Points for Enhancing Group Discussions

- Increasing time allotted for small group discussions.
- Reserving quiet spaces for attendees to use throughout the Summit as needed.
- Creating additional opportunities for attendees to contribute to topics that generate actions that they can bring back to their organizations.
- Having more focus on the specific actions that will be taken by policymakers in relevant sessions throughout the Summit.

Points for Enhancing Broader Representation and Engagement

- Including more self-advocates and persons with lived experience throughout all sessions.
- Adjusting the duration of each sessions, including shorter talks.
- Including a poster session highlighting Autism Alliance of Canada's ongoing work.
- Building additional opportunities for attendees to engage beyond table discussions.
- Including a discussion or presentation about learnings gathered from countries that have autism strategies in place, especially highlighting what has worked and what has not worked.

Points for Enhancing Accessibility

- Catering towards the specific and diverse needs of Autistic attendees.
- Providing live or closed captioning for all presentations.
- Encouraging more accessible and concisely-worded questions during discussion sessions.

Learnings to incorporate in future Summits

To ensure greater satisfaction, accessibility and inclusivity, Autism Alliance of Canada plans to incorporate the following learnings to the 10th Annual Canadian Autism Leadership Summit (CALS2024):

- Prioritizing a larger location to ensure a more accessible experience for attendees.
- Including a poster session to highlight notable projects and research initiatives.
- Increasing involvement of Autistic persons and persons with lived experience throughout the Summit.
- Encouraging presenters to use plain and accessible language and to refrain from using metaphors as descriptors.

- Distributing session materials ahead of time for attendees to review as needed.
- Channeling to audio through the microphones and speakers in the room to create a more focused experience.
- Encouraging attendees to silence their devices to minimize distractions.
- Encouraging participants and presenters to identify themselves before speaking.
