Since our founding in 2007, we have grown from a small operational board to a member-driven network grounded in a shared purpose and deep community roots. This past year marked a significant milestone in our journey: we officially became a registered charitable organization, solidifying our long-term commitment and growing capacity to drive change at scale. These pillars guide every step we take: defining our priorities, informing our partnerships, and anchoring our accountability to the communities we serve.

Our mission is to inform policy and practice at a national level by bringing our members together, identifying priority issues, and developing meaningful ways to address them.




We take a collective impact approach, aligning our efforts around five key principles:

## **Building a Shared Policy Agenda**

# Canada's Autism Strategy

In 2024, the federal government released Canada's firstever National Autism Strategy. This milestone is one of the most significant systems-level policy wins for Autistic people in Canada's history.

We're helping make sure it leads to real change for Autistic people and their families - by bringing the lived experience, the right evidence and partnerships to the table. This is how systems change happens - through leadership that connects community voice with government action, and turns advocacy into impact.

Autism Alliance of Canada not only championed this vision; we helped build it from the ground up. From leading national consultations to shaping the Strategy's Blueprint and Roadmap, the Alliance is now supporting its implementation. Over the years, we worked directly with federal partners to ensure this strategy was rooted in lived experience, informed by evidence, and aligned with the needs of Autistic people and their families.

#### **Why This Matters**

Canada's first National Autism Strategy is more than a policy milestone—it's a lever for social change. With more than 1 in 50 Canadians on the autism spectrum, this strategy has the potential to reduce long-standing inequities in healthcare, education, employment, housing, and human rights. It paves the way for coordinated investments, measurable outcomes, and better use of public resources. By helping inform this strategy, Autism Alliance of Canada is advancing:

- · Health equity by promoting early access to care and culturally responsive services
- Economic participation by addressing barriers to employment and skills development
- Human rights and dignity by embedding lived experience into public policy

#### **National Autism Network**

As a founding partner of the newly established National Autism Network, we are advancing the next phase of implementation by:

- Bringing together Strategic Priority Committees that will provide expert, cross-sectoral
- guidance to the Public Health Agency of Canada
- Embedding lived experience so that Autistic people and families directly inform national implementation
- Ensuring knowledge translation happens in a timely way throughout the Network



## **Strengthening our Collective Voice**

We bring together people from across sectors—including autistic individuals, caregivers, researchers, clinicians, educators, and policy leaders—to collaborate on real-world solutions to the challenges facing Autistic people in Canada.

In 2024, we strengthened our national convening power by fostering cross-sector partnerships, co-developing guidance for the implementation of Canada's Autism Strategy, and embedding lived expertise across all major initiatives. By connecting voices and expertise, we amplified collective action across Canada's autism ecosystem.

# **Canadian Autism Leadership Summit**



The 11th Annual Canadian Autism Leadership Summit (CALS2025) convened a powerful cross-section of perspectives - Autistic self-advocates, researchers, policymakers, service providers, and families - to push forward the national conversation on autism policy, inclusion, and action. Held under the banner of collaboration and community, CALS2025 featured thought-provoking keynote addresses, breakout sessions, and panels aligned with the priorities of Canada's newly released Autism Strategy.

## **Key Highlights of CALS2025**

- Elder Vince Kicknosway opened CALS2025 with a grounding welcome, followed by Senators Marilou McPhedran, Wanda Thomas Bernard, Leo Housakos, and Jim Munson, along with Chief Accessibility Officer Stephanie Cadieux, who emphasized grassroots leadership, intersectionality, and the importance of lived experience in shaping policy.
- Breakout sessions and panels addressed all five priority areas of Canada's Autism Strategy, with focus on neuroinclusive housing, education reform, access to diagnosis, public awareness, and economic inclusion. Speakers called for community-led, data-driven approaches to close systemic gaps.
- Dr. Karen Bopp introduced the new National Autism Network, a new independent organization funded by the Public Health Agency of Canada
- The Jim and Ginette Munson Autism Leadership Award was presented to Kelly Bron Johnson for outstanding advocacy.

 CALS2025 prioritized inclusion through livestreaming, barrierreduction supports, and financial assistance for participants with lived experience.

 Tanya McLeod of The Sinneave Family Foundation closed with a call to unite research, lived experience, and policy to drive measurable change.

## **Strengthening our Collective Voice**

### **Canadian Journal of Autism Equity**

Launched in 2021, the Canadian Journal of Autism Equity (CJAE) is an open-access digital publication, funded by the Sinneave Family Foundation and housed by McMaster University Library. It addresses critical equity challenges within the autism community and public policy by centring Autistic voices and lived experience often missing in traditional research. In 2024/25 CJAE published two volumes:

<u>Vol. 4 No. 1 (2024)</u>: Autistics and Housing highlighting the importance of access to supports in achieving housing stability and quality of life. Through a combination of research and compelling stories, this edition seeks to inform social policy and better address the housing needs of Autistic Canadians.

<u>Vol. 5 No. 1 (2025)</u>: Autism and Diagnosis focused on the theme of diagnosis. It features a diverse collection of research, narrative, poetry, and art that explore the diagnostic process and its outcomes, including access to services and accommodations. The edition aims to provide insights into the experiences, challenges, and implications surrounding diagnosis.





### Barriers to Healthcare for Minority-Language Children on the Autism Spectrum

Partnering with researchers from McGill University, Université de Hearst, and Dalhousie University, this project captures the lived experiences of people on the spectrum and their families who don't speak the language of the majority in their communities while getting autism services and supports.

#### Lived Experience of Black Youth-Led Collective of Racialized and Neurodiverse Youth and Adults, with Employment in Canada

Launched in 2024 with funding from Inclusive Design for Employment Access (IDEA) through the New Frontiers in Research Fund – Transformation, this project is a collaboration with the Youth Alliance for Intersectional Justice. It explores the employment experiences of a Black youth-led collective of racialized and neurodiverse youth and adults in Canada. A testimonial video series will challenge myths about hiring Autistic and racialized youth, highlighting intersectional barriers. The series will be accompanied by an updated resource list to support inclusive hiring by employers and agencies.

# Expanding the Francophone Collective Voice

Autism Alliance of Canada is committed to deepening its engagement with French-speaking communities through the Francophones mobilisés: unissons les voix de l'autisme à travers le pays project. With funding from Employment and Social Development Canada, we are focused on empowering Francophone organizations and individuals to promote culturally inclusive approaches that reflect the unique needs of Francophone Autistic people and their families.

# Honest Conversations Podcast Series

Shortly after the release of Canada's Autism Strategy, Autism Alliance of Canada launched Honest Conversations, a limited podcast series. Hosted by Ally Garber, a longstanding member of the Alliance, mental health advocate, and public relations specialist, the series explores the priority areas of the

Strategy through insightful discussions with experts and community leaders, offering fresh insights into the pressing issues facing the autism community.



# Ready, Willing & Able

Over the 11 years, Ready, Willing and Able (RWA), a joint initiative of Inclusion Canada and Autism Alliance of Canada, has transformed the landscape of inclusive employment across the country for people with intellectual disabilities or on the autism spectrum.

By fostering inclusive hiring practices and connecting employers with job seekers who have historically been overlooked, RWA is redefining what equitable workforce participation looks like in Canada.

As we celebrate the 10th anniversary of the Ready, Willing, and Able (RWA) program, we are filled with pride and gratitude for the incredible journey we have undertaken as a community. Over the past decade, RWA has (in partnership with 200+ supported employment agencies across the country), transformed the landscape of inclusive employment in Canada; helping to shift the paradigm from a charity-based model to one that recognizes the immense value of people with intellectual disabilities and those on the autism spectrum as contributors to our economy and society.

Since its inception, RWA has facilitated over 5,000 employment outcomes for individuals on the autism spectrum or an intellectual disability. These outcomes vary across every sector and industry and were achieved without the use of wage subsidies, ensuring that these roles were competitively paid and valued. Our work with more than 20,000 employers, including 20 National Employer Partners, across the country has demonstrated time and again that inclusive hiring is not just the right thing to do – it is the smart thing to do.

## **Accelerating Research and Data**

# Grounded in lived experience to drive national systems change through collaboration, evidence, and lived experience.

In 2024, we helped build a shared national policy agenda that reflects the real needs of autistic people across the country. Canada lacks data on the number of Autistic people, how their needs evolve over time, and where the most significant barriers to care, education, and inclusion exist. Without in-depth data, it's the most marginalized who fall through the cracks.

Autism Alliance of Canada has been steadily building the infrastructure for impactful, community-driven research that directly informs autism and disability policy. With early support from the Azrieli Foundation in 2021, we established foundational capacity that catalyzed over \$2 million in research and data initiatives, investments that continue to shape systems and policy research across Canada today. These partnerships with research institutions, funders, and community organizations deepen our capacity for evidence-informed policy development.

Building on this foundation, in April 2024, a \$10 million investment established the National Centre for Autism Collaboration (NCAC) to accelerate the impact of evidence-based solutions for Autistic people and their families across Canada. Led by a \$5 million leadership gift from the Joyce Family Foundation and matched by Hamilton Health Sciences Foundation, The Sinneave Family Foundation, McMaster University, and McMaster Children's Hospital, the NCAC reflects a shared commitment to building lasting infrastructure that bridges research, policy and practice.

Through the NCAC, the Alliance is co-leading research projects with leading scholars, tackling complex systems-level challenges such as national waitlists, data harmonization, and health equity. While the NCAC marks a significant achievement, it represents more than a one-time outcome: it is a key milestone in Autism Alliance of Canada's broader journey toward long-term sustainability and capacity-building. The NCAC will fuel the research and data engine of Autism Alliance of Canada, anchoring our research portfolio and providing infrastructure needed to move knowledge into action. It will also support the implementation of Canada's National Autism Strategy.

Bridging research and policy to support evidence-informed decision-making at every level
Driving accountability by co-developing transparent monitoring frameworks and implementation metrics
Scaling partnerships with government, civil society, and academic institutions to align efforts and maximize national impact.

If we want a Canada where Autistic people can live full, connected, and meaningful lives, we must start by knowing who we're serving—and act on that knowledge with fulsome policies, neuro affirming health care and education, and inclusive practices. That's why how we use autism data matters just as

## **Research Pillars**

#### Data & Science Hub

Empowers researchers by improving access to datasets-helping identify gaps and unlock solutions in clinical care, services, and public policy across Canada.

#### **Policy Collaborative**

Creates space for members, researchers, and advocates, to unite, ensuring governments at every level are equipped with timely evidence and lived experience to inform policy.

#### Knowledge & Evidence Synthesis Portal

Mobilizes high-impact projects that gather and translate evidence into best practicesguided by priorities identified by members of the Alliance.

### **Training Collaborative**

Builds the next generation of leaders through fellowships, scholarships, and mentorships opening pathways into autism research, clinical practice, and policy innovation.

## **Training Collaborative**

The Alliance's commitment to training the next generation of researchers and policy leaders is exemplified through the D2P Fellowship and the Canadian Institutes of Health Research (CIHR) Health System Impact Fellowship. Together, these programs have supported over 10 trainees to date. These fellowships are intentionally structured to centre lived experience, translate findings into practice, and embed research expertise into real-world decision-making.




## **Operational Excellence**


## **Financial Summary**


